Notice is hereby given that Lavenham Parish Council have submitted a modified version of their Neighbourhood Plan (also known as 'LNP2') to Babergh District Council under Regulation 15 of the Neighbourhood Planning (General) Regulations 2012 (as amended).

#### **Consultation on the 'Plan Proposal'**

In accordance with Regulation 16, Babergh District Council will commence consultation on the submission draft LNP2 on Monday 3 July 2023.

Comments are invited from those who live, work and carry out business in the designated area (the parish) on whether the 'plan proposal' as submitted (the draft Plan and supporting documents) fulfils the basic conditions required by Paragraph 8(1)(a)(2) of Schedule 4B to the Town and Country Planning Act 1990 (inserted by the Localism Act 2011).
